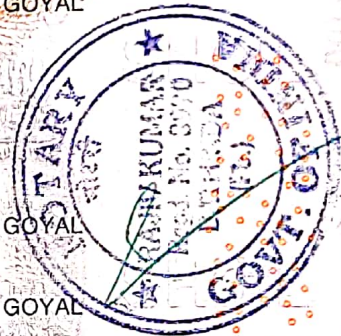




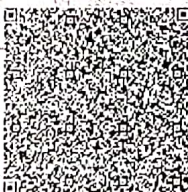

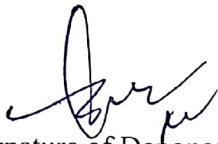
9. The details of staff appointed shall be displayed on the official website of the institution i.e. www.ssdgc.com (website of the institution).
